INVESTMENT OBJECTIVE

The Starfunds.ai BCI Stable Fund of Funds aims to deliver a stable level of income combined with long term capital stability.

INVESTMENT POLICY

The portfolio's equity exposure may be as high as 40% of its net asset value in order to provide a level of capital protection. Investments to be included in the portfolio will, apart from assets in liquid form, consist of participatory interests and other forms of participation of local and global collective investment schemes, or other similar schemes. The investments will be consistent with the portfolio's primary objective, investing in equity securities, property and property related securities, notes, non-equity securities, money market instruments, financial instruments, bonds and other interest-bearing instruments and securities. For the purpose of this portfolio, the manager shall reserve the right to close the portfolio to new investors in order to manage the portfolio in accordance with its mandate.

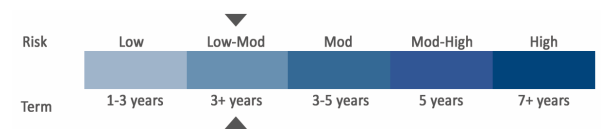
