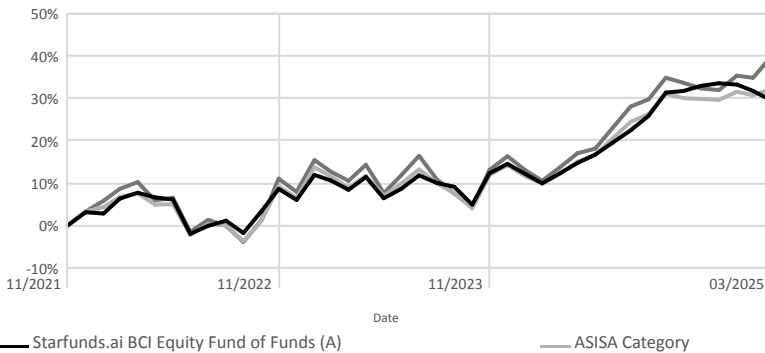
INVESTMENT OBJECTIVE

The Starfunds.ai BCI Equity Fund of Funds objective is to provide investors with high long-term capital growth.

INVESTMENT POLICY

The fund is a general equity portfolio that aims to provide investors with high long-term capital growth. The portfolio's net equity exposure will be a minimum of 80% of the portfolio's asset value. Apart from assets in liquid form, consist of participatory interests and other forms of participation of collective investment schemes, or other similar schemes registered in South Africa and which is consistent with the portfolio's primary objective, investing in amongst others equity securities, property securities, non-equity securities, money market instruments, preference shares, listed and unlisted financial instruments and interest-bearing instruments and securities.

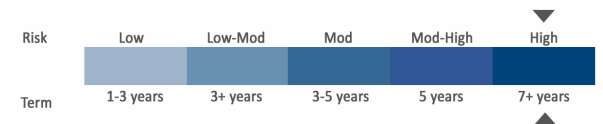
