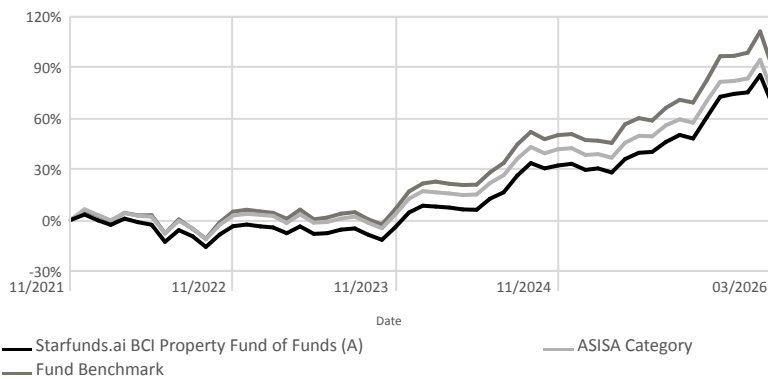
INVESTMENT OBJECTIVE

The Starfunds.ai BCI Property Fund of Funds objective is to provide investors with moderate long-term capital growth.

INVESTMENT POLICY

Investments to be included in the portfolio will, apart from assets in liquid form, consists of participatory interests and other forms of participation of collective investment schemes, or other similar schemes registered in South Africa and which is consistent with the portfolio's primary objective, investing in amongst others equity and property securities, including companies that derive a material portion of their income from property investment, property collective investment schemes, property loan stock, interest bearing instruments and securities, preference shares, non-equity securities, financial instruments and assets in liquid form. The portfolio will invest at least 80% of its market value in portfolios that invest in shares listed in the FTSE / JSE Real Estate industry group or similar sector of an international stock exchange and may include other high yielding securities from time to time. Such underlying portfolios may invest up to 10% the relevant portfolio's assets outside the property sector in companies that conduct similar business activities.

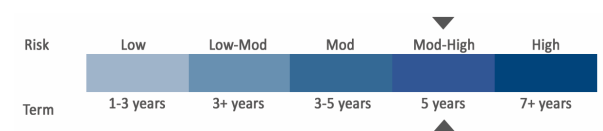

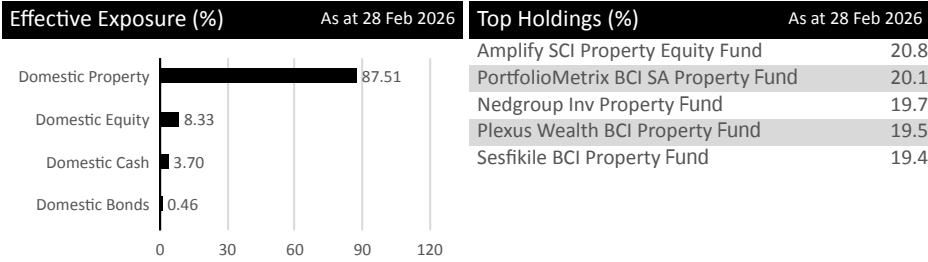
