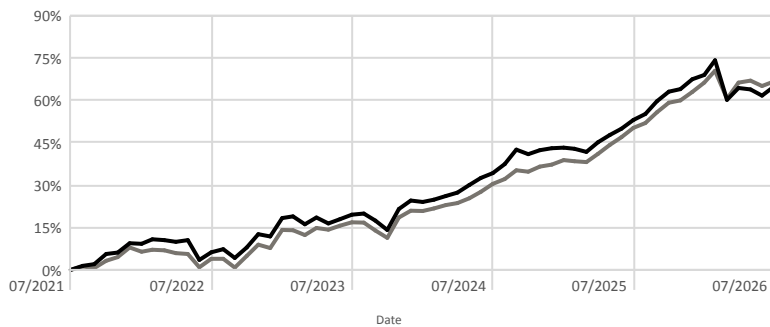
The Starfunds.ai FR Balanced Fund of Funds aims to provide the investor with a moderate level of income and long term capital growth.

INVESTMENT POLICY

The portfolio's equity exposure on a look through basis will range between 0% and 75% of the portfolio's net asset value. Investments to be included in the portfolio will, apart from assets in liquid form, consist of participatory interests and other forms of participation of local and global collective investment schemes. The underlying portfolios will invest in, amongst others, equity securities, property securities, non-equity securities, interest bearing securities, money market instruments, preference shares, listed and unlisted financial instruments, bonds and other interest bearing instruments and securities.

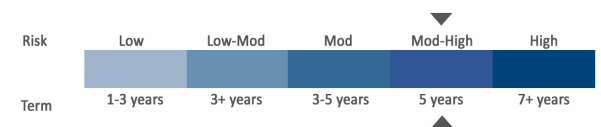

Moderate - High Risk
